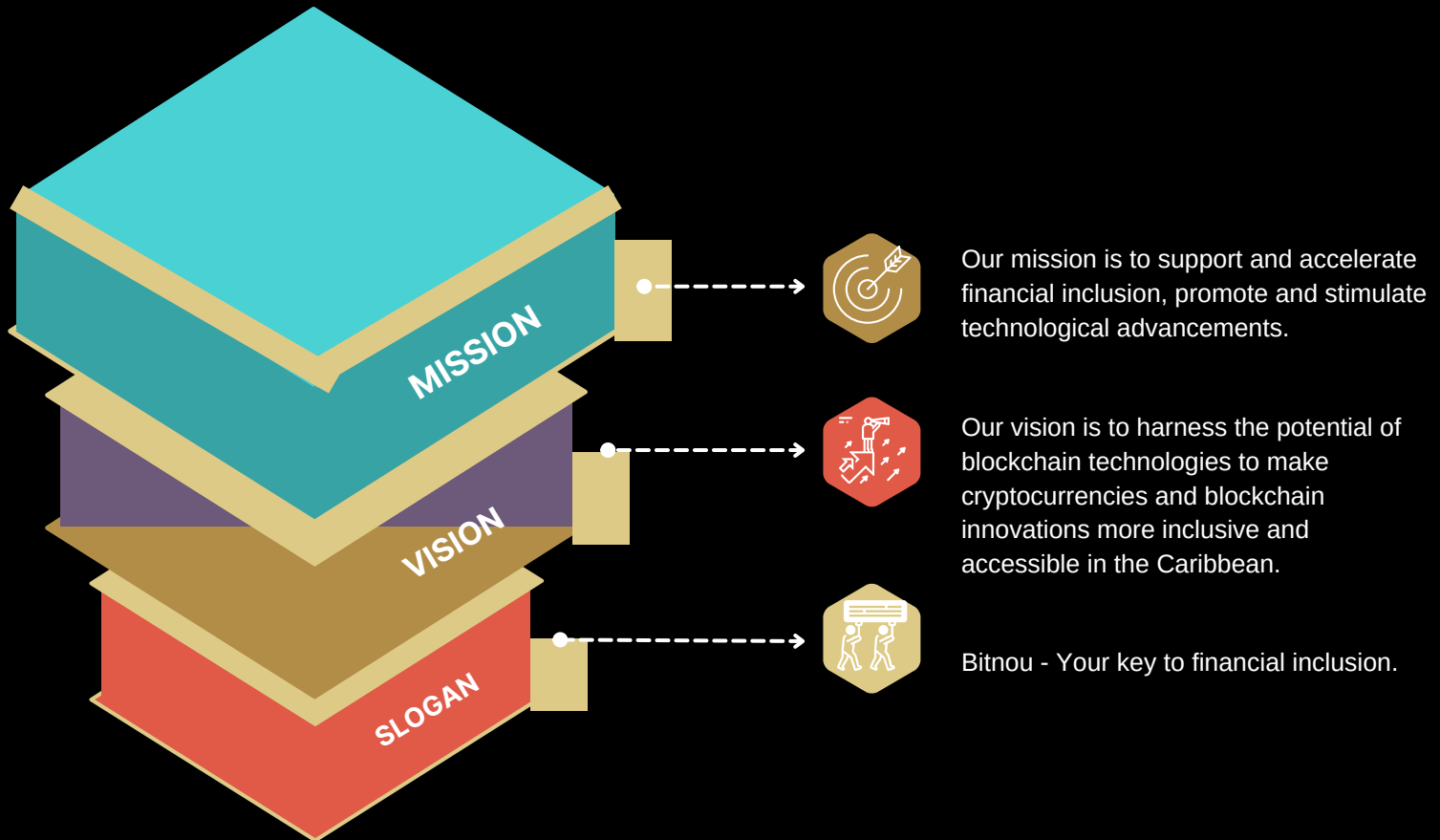
# Introduction to Bitnou Ecosystem

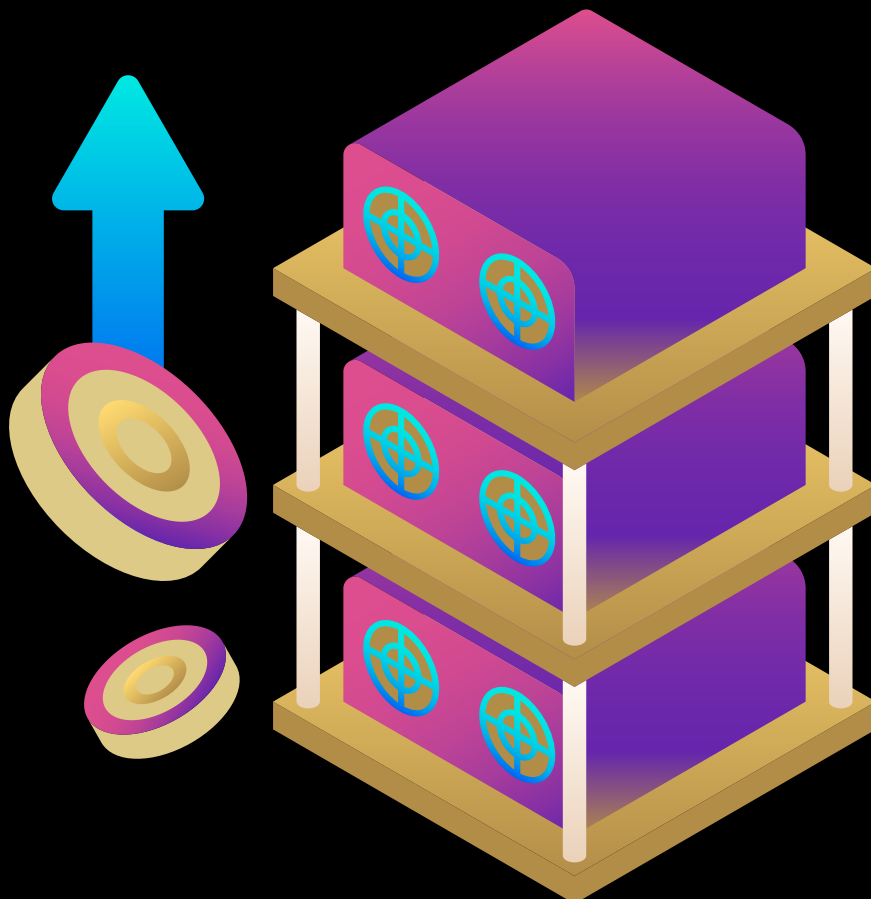

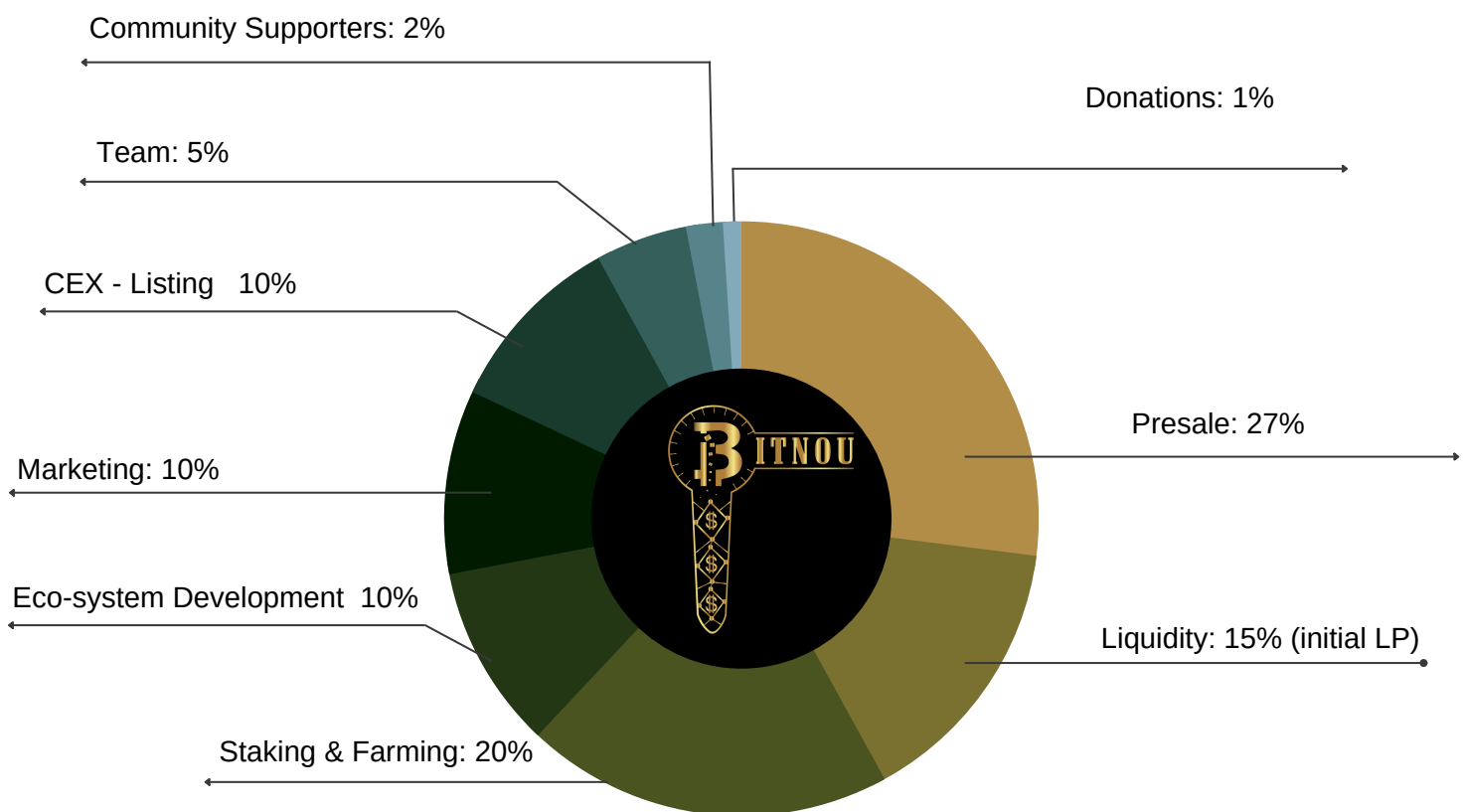
